Field dragger – We need to purchase “vibrating shanks” (two different sizes – small/medium) so that we can utilize the field dragger. These are what is placed into the direct and the sizes determine the depth of breakup in the dirt.

- Addison is planning to have a meeting in the spring with those people who would use the field dragger to demonstrate how to use it.

- The field dragger is currently in the concession stand until we find room for it in the equipment shed.
