NSF Check-Jen will reach out to this parent to get another check reissued to us for Spring 2026 registration.

Pool Check for end of season party-Jen sent the check to the PO Box for the pool.

Fall registration: As of 7/12 there are 24 total registrations for fall ball. 8-8u, 11-10u, 4-12u, and 1-14u. It was determined that there would most likely be no 14u team for the fall season, and we discussed the possibility of the one registered player playing for 12u instead. Jen will reach out to the league to double check that they are ok with that.

Troy Summey will be holding open fields for all 10u eligible players from 6-8pm on Wednesdays starting this week (7/15.) He asked that we advertise this on Facebook. Along with that we will also post a reminder about registration and about the mum fundraiser.

Fall Tournament: We discussed HGSL holding a fall tournament for either 12u or 10u. It was mentioned that our fields would only allow for one field to be used for 12u because of the pitching mound. We decided because of that, we would hold a 10u tournament so that we are able to use more than one field. It was decided that the weekend of 10/17 would work best and we would like to have 8 teams. The cost would be \$125/team. Jen will make a flyer to distribute, and Addison will reach out to umpires.

Sign up genius for concession donations/volunteers: Allie will be working on creating a sign-up genius for concession stand donations and for volunteers once our game schedules have been determined. We will be asking parents for donations of water, Gatorade, soda, plates, condiments, utensils, and chips. We decided to send out the donations sign up separate from the volunteer sign up.

Winter Open Gyms: Lindy contacted Camp Hebron about reserving their gym in the winter for our open gyms. She reserved Sundays from 1-7pm starting January 17, through March 7. The cost is \$600 for 8 weeks. Jen approved this purchase, and Allie 2nd. We will need a check sent to them for this. Lindy will send over the contract for Jen to sign and Jen will send them the check.

August 16 will be our next board meeting and we will add that to the website.
