### Other:

Kristin will help with the current signup genius but she is going to resign due to busy schedule. Kristin gave her concession stand key to Emilia.

Kristin brought some concerns from the 10U Gold parent to the board. Essentially it seems as through the parents feel the way that the teams were split was unfair with a "stacked" team and a less experienced team. The Gold team players are discouraged. We are setting up one team to win and the other to lose.

Apparently, there have been some unkind comments made by Black team players to some Gold team players. Kids at school cheering for the Black team but not the Gold team. There is some concern that girls will not want to play next year and families will not sign their children up to play.

Previous years there have been similar concerns but teams have pushed through. Previously, parents were told that there is a learning year when you move up to a new division and then the second year is usually where teams are more competitive.

Siblings should be on the same team. There was a misunderstanding about one player playing on both 10U teams for games but she could only play on one team (her rostered team) for the midseason and playoff tournaments.

This year there was a greater number of new girls to the 10U division. It made the division of experience more evident between the two teams.

- -Suggested to ask permission for those brand new girls to play down a division for their first year so that they can get some basic skills.
- -Can practices be meshed together early in the season (almost similar to open gyms/fields) to work on basic skills and ensure that girls are working on similar skills/learning the same thing? However, this can only be done to a certain extent. Eventually the teams will need to do their own practices/skill building drills.

Bad attitudes and no desire to be at practices or games made it difficult for girls to want to play on teams. Girls not coming to practices or games can bring down the team as well.

Is it better to play 2 innings on a winning team or play all innings on a bad team??? Again, these are questions we cannot easily answer.

A try out was suggested however that may also cause a separation of experience. Would players be cut?

We do not want to miss out on girls playing but where do we draw the line that skills need to be met in order to be on a team?

Jen reached out to other town/league Presidents and the Perry County Board to see how teams with more than one team were splitting their players. She was told that players stick with their coaches, not drafted each year. If there are new girls or a team is split up due to a coach moving up or not coaching any more then those players are drafted by current teams.

→ Should we have a written policy for parents to know how teams are split and organized? Coach's child(ren) are on the coach's team. Siblings are on the same team regardless of age as long as they are within the same division. Possibly if coaches both agree to a draft then a draft can happen instead of players staying with the same coach? – There is some complications that can come about from that such as a team splitting in half from one season to the next, coaches may feel pressure to draft from another coach, players are learning from different coaches (not necessarily a bad thing but it may be hard for players

at times if they learn one way then need to relearn it a different way. Coaching styles differ as well).

→ We can write something up and present it for our annual general meeting at the end of the year. Then it can be added to the bylaws.
