Secretary – Meeting minutes from 9/7/25 Jen motioned to approved, John 2nd.

Treasurer's report -

Checking \$5,131.95 Fundraising \$12,094.89

Field dragger purchase:

Quote for \$4,999 (dragger with profile blades...etc) – there are optional things we can purchase later on that can be added to this machine. It can be stored in the shed if we consolidate some things. We put a lot of money into the fields, we need to take care of them and this will make it easier to do that. Lindy mentioned that we could possibly put in a grant to recover some of the funds used to purchase this equipment. Jen motioned to approve this purchase and John 2^{nd} it. The money will come out of the fundraising account.

Halloween Parade: October 25, 5:00 – 7:00 pm (check in at band stand 3:30 – 4:30 pm) Jared Corsnitz will pull a hay wagon for us. We will need someone to man the wagon during the parade as Lindy, Megan and Jen all have plans. Lindy can register our wagon, add our registration sign, and get the candy to the parade. Lindy is going to reach out to Megan and Rob Pricket t to see if they would be willing to help and chaperone the girls during the parade. We approved to purchase ~\$250-300 worth of candy plus we will ask girls to bring some candy to hand out as well.

Concession stand "Clean out"/Wing Night - October 17?

According to the square app, we earned \$2,430.32 in the concession stand during the fall ball season (roughly 5 weeks in length) and \$263 was charged on cards since the end of August.

Clean out the concession stand on October 16. We will hold off on the wing night. Put up a facebook post to support our players for the last game of the season, Taco Tuesday and to "clean" out the concession stand during our last home game (October 14).

Fall clean up date(s):

Turf spread, clean out concession stand, shut off water, take down banners Carter Enders gave a quote for \$425 to level stone, put astro turf down with the second batting cage area. This would give us a second batting cage that would be almost identical to our current batting cage that we cleaned up and modified during spring clean up. Funds

for this would be taken from the checking account. Jen motioned to approve this expense. John 2^{nd} .

Some things to keep in mind for spring maintenance: Scott Corsnitz is willing to mow the grassy area across from filed 1 each week. Carter Enders gave us a quote for \$95 to mow all three fields – should we fundraise and have a set contract with Enders Landscapes to maintain the grassy parts of the fields? Does this include the hill and spectator areas? He also provided a quote for \$225 to spray the fields/property and a final quote for Aeration and seeding of grass in the spring (\$250 to rent the aerator machine) for a total of \$920.

We would like to get a new flag – Erin Miller had mentioned she could obtain a new flag for HGSL. Also, we should look into a solar powered light to light up the flag as well.
